# Georgia State and University of Pretoria Sign MOU

AYSPS Collaborates on a Graduate Degree Program in Taxation

Upholding the long-standing relationship with the University of Pretoria, Georgia State signed a Memorandum of Understanding (MOU) to honor the collaboration between the universities. As a part of the agreement, the Department of Economics in the Andrew Young School of Policy Studies (AYSPS) has facilitated instruction on a graduate degree program in taxation within the University of Pretoria's African Tax Institute in their Department of Economics. Delegates also discussed establishing initiatives in language, economics, social work, geology, and to pave the way for further engagement on policy issues related to megacities.

"All of us benefitted from the discussions of the work that the top South African universities are doing around city issues," said AYSPS Dean Mary Beth Walker. "We will realize significant gains in expanding our research collaborations with South African universities."
