After much work from everyone in AYS, the faculty passed the new strategic plan last May by an overwhelming positive vote. The plan articulates four main goals of preparing future leaders, expanding the solid foundation of innovative and interdisciplinary research, raising the profile of AYS globally, and expanding our organizational structures to support academic and research excellence. Based on a series of meetings and sessions with faculty, staff, stakeholders, and students to elicit feedback, the plan was drafted to have

relevance for all of the units within our School. Many thanks to the Steering Committee for leading this process to a successful ending.

I am sure that everyone spent their summer wondering – what's happening with the strategic plan now? Actually, a lot did take place over the summer months. In August, I presented the plan to Provost Palm who provided her support for the plan, and her reflection that we matched the GSU plan well. She did suggest some minor changes in wording. With those suggestions from the Provost, we then presented the plan to the University Administrative Council in early September. The other Deans and University administrators also gave a "thumbs up" to our plan.

The next steps are developing an implementation strategy. Nancy Kropf, our Associate Dean for Research and Strategic Initiatives, and I will be putting together a framework to start this process.
