Once again, let's celebrate the successful outcomes of two external review teams' recent evaluations of all PMAP programs for 1) an academic program review (APR) and 2) to assess the MPA program for re-accreditation. Possibly my favorite line was that our "national ranking is trailing its level of achievement," even though U.S. News ranks the **Andrew Young School of Policy Studies** No. 23 among the nation's 260-plus graduate schools in public affairs.

The APR team noted our "very strong degree programs at the undergraduate and graduate levels ... and overachieving Ph.D.

program," for the quality of instruction and internship experiences. "The track record of Ph.D. placements suggests a doctoral program producing well-trained scholars at a top five level nationally," it reported.

And after its review, the chair of the Network of Schools of Public Policy, Affairs, and Administration (NASPAA) review team requested permission to share the AYSPS's assessment of student competencies and its diversity plan at his college, writing "They really are models to emulate." Congratulations to Chair Greg Lewis and our PMAP faculty, staff and students on a job well done!



## PMAP Graduate Students Compete Regionally and Nationally



Angela Smith (M.P.P. '15), was part of the Southeast regional winning team of the Network of Schools of Public Policy, Affairs and Administration's (NASPAA) 2015 Inaugural Student Simulation Competition on February 28, 2015. The daylong event brought together 45 teams of graduate students representing 93 participating NASPAA

schools across the U.S. at five regional sites and challenged them to provide a locally led "bottom up" approach to health care reform. Ten-minute presentations from each team were evaluated by a panel of policy practitioners. Smith's group included a student from the University of Alabama at Birmingham and the University of South Florida.
