This week includes a number of orientation events for new faculty and staff. Here in the Andrew Young School, we have several new and outstanding faculty and staff members. 

**Bride**, an expert in the field of secondary traumatic stress and compassion fatigue, comes to the AYS from the University of Georgia, where he directed the School of Social Work's Ph.D. program. A licensed clinical social worker, Bride taught at the University of Georgia for 10 years. Prior to that, he was on the faculty at the University of Tennessee. He holds a Ph.D. in Social Work from the University of Georgia, an M.P.H. from Harvard School of Public Health, an M.S.W. from Florida State University, and a B.S. from the University of Florida.

Prior to UM, Wright was a senior research associate in the Institute of Criminology at Cambridge University in the United Kingdom. He holds a Ph.D. in Criminology from the University of Cambridge and an M.A. and B.A. in Social Ecology from the University of California, Irvine.
